SPACE IS LIMITED! Will be going from 30 vendor spaces down to 9. This will be **First come, first serve**; meaning the first 9 to submit payment **and** a completed form will get booth space. Each booth is \$100.00 (inside or outside) for the duration of the Fair and is **non-refundable**. **Gate entry wristbands for booth workers will NOT be provided.** Make checks payable to Jackson County Ag Society. Arriving and Unloading at the Fair:

You may drive in front of the Milt Lunda Memorial Ice Area **on Wednesday ONLY!** Use Gate 4 off Pine View Road. **No parking is allowed on Fairgrounds.** **If you come after Wednesday, you must unload in the back of the Ice Arena.** Check with the Fair Office if you need to be shuttled to and from your vehicle. We will try to accommodate you.
